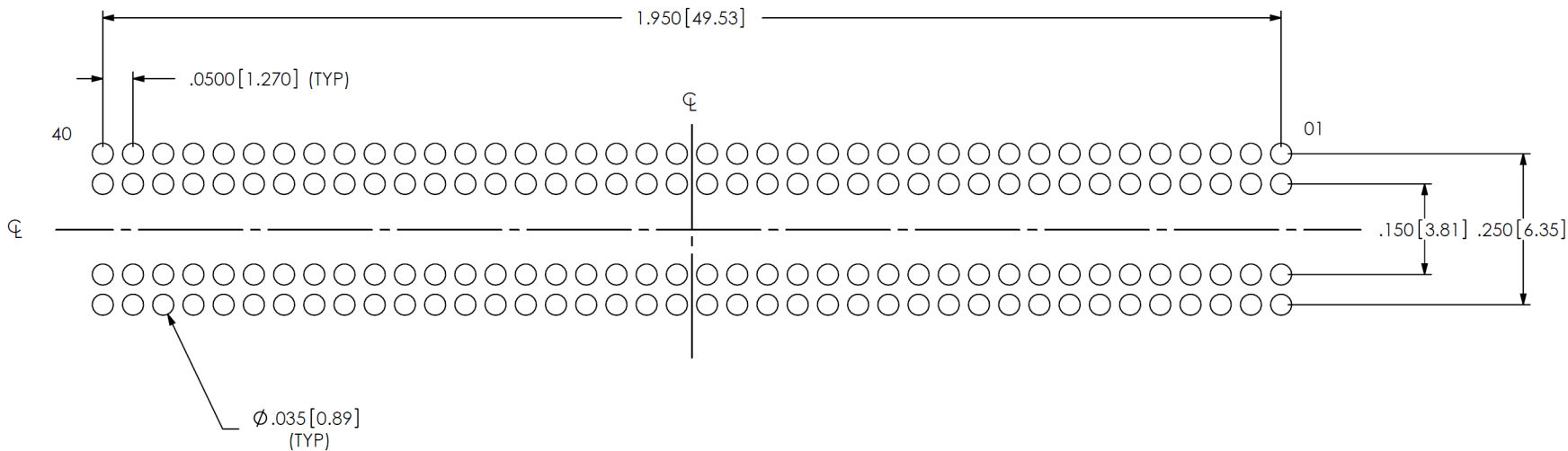


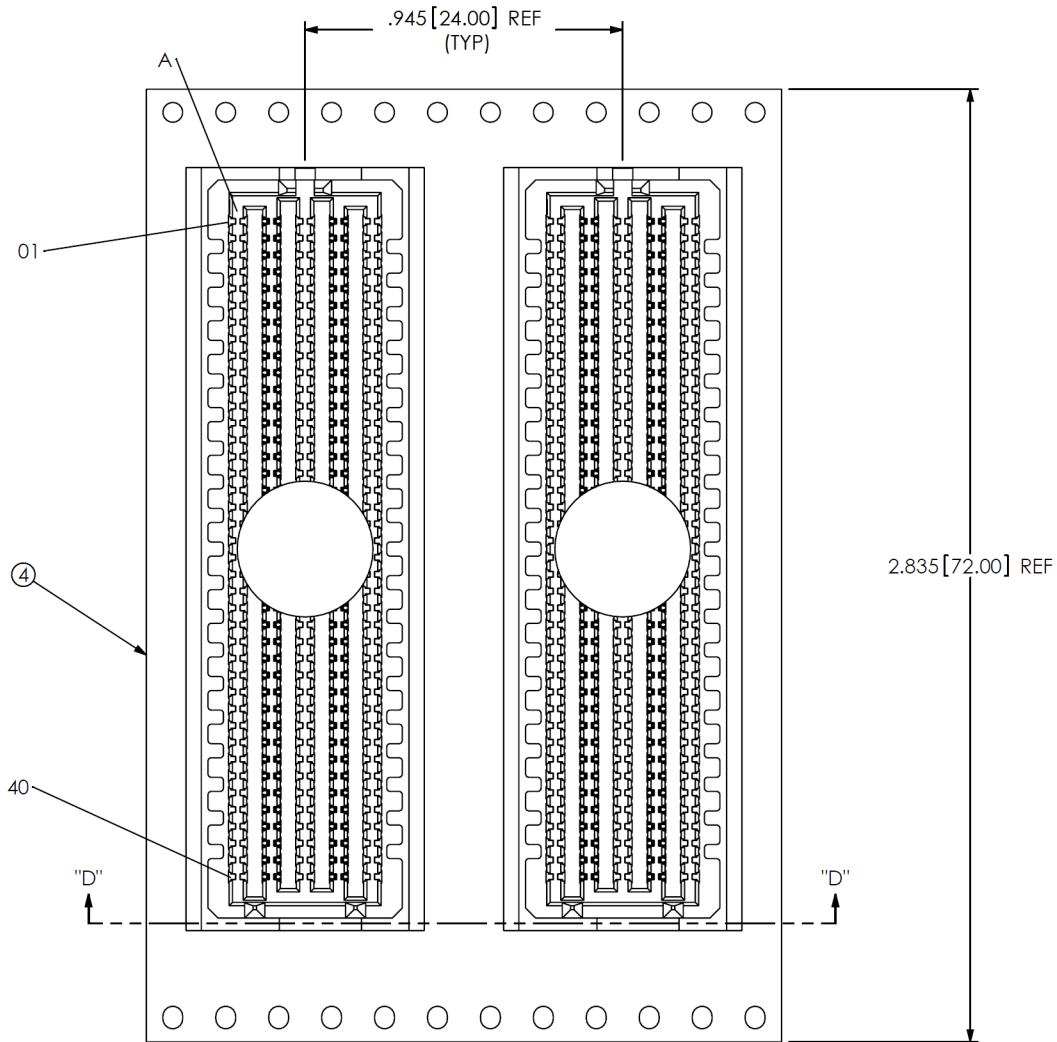

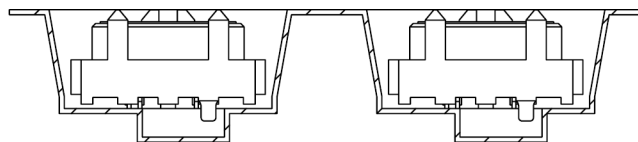
RECOMMENDED STENCIL LAYOUT FOR ASP-134604-01
